Parental Consent

I (We), the undersigned, do hereby give permission for my (our) child, _____

Furthermore, I (we) on behalf of my (our) child-participant (if under the age of 21) hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein.

Furthermore, authorization and permission is hereby given to said church to furnish any necessary transportation, food and lodging for this participant.
